**1.2 ELIGIBILITY**

In accordance with the provisions of Schedule A Section 2, the GZU Students 'Executive Council Constitution, Persons who are registered as students with GZU and obtained Students Identification Cards shall be entitled to stand as candidates on condition that they:

- Have not been convicted of a criminal offence in a court of law;
- Have not been found guilty by the University Disciplinary Committee of a case of misconduct or by any other institution of higher learning;
- Have not been expelled from any other institution of higher learning;
- Are not in their final year final semester for the sake of continuity;
- Have passed all their modules for the previous semester, this shall not apply to first year students in their first semester who wants contest;
- Have not served in the Students Representatives Assembly for two terms.

**NB:**

- There shall not be any racial, tribal, regional or gender discrimination of aspiring candidates.
